Methodology

- The Benenson Strategy Group conducted 1201 telephone interviews of likely voters nationwide between October 8th and October 15th, 2007.
- ❖ The margin of error is ±2.83% for the entire sample at the 95% confidence level and is higher among subgroups.
- All numbers displayed are percentages.
- Eight focus groups with a total of 69 respondents were conducted in Cleveland, OH, Fairfax, VA, Denver, CO and San Francisco, CA from September 12 – 20, 2007. Groups were separated into two types - white, middle-class likely voters with no more than a college education, and upper-middle class "opinion-leader/elite" voters with a demonstrated interest in news and current events. In each city, one group consisted entirely of men and one entirely of women.

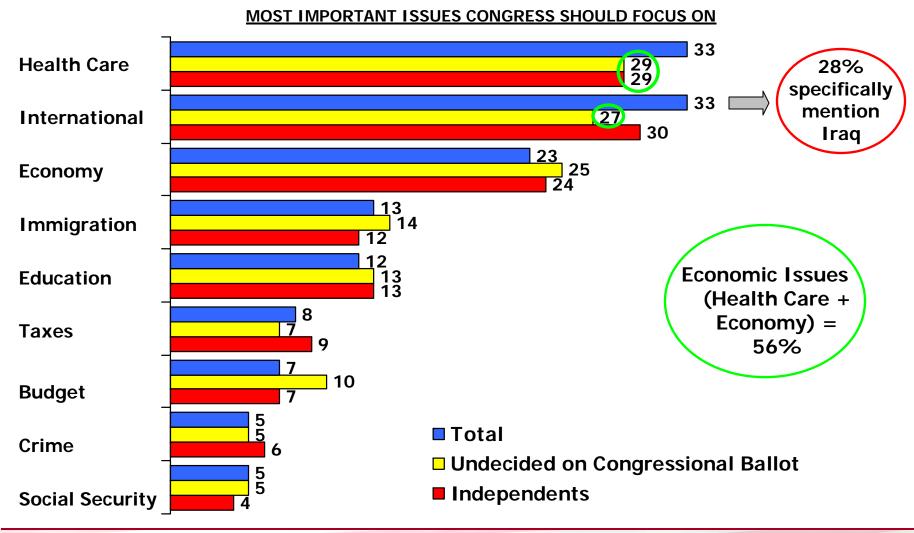


Key Findings

- Lack of confidence in the economy or the economic leadership of the GOP
- But neither party is seen as offering a better way to grow the economy
- One key challenge is addressing the impact of globalization
 - Current choice seems to be: soften the impact or ignore it
 - > The real choice: soften or find how we succeed under it
- Optimism is under siege but Americans see a key strength that usually makes Americans uniquely able to bounce back: our freedom of ideas and capital
 - Ideas are seen as a key source of jobs
 - Business knows this, but policy makers are seen as less responsive
 - Because the profit motive drives new ideas, most say central to our success is making sure trade agreements ensure that innovation is rewarded.
- Support for an innovation-based agenda fits in a larger agenda that includes:
 - Making health care more affordable;
 - Developing alternative forms of energy;
 - Addressing the budget deficit (but notably concern about the need to invest in education, health care, and innovation trumps the need to address the deficit);
 - Helping companies protect ideas and innovations.

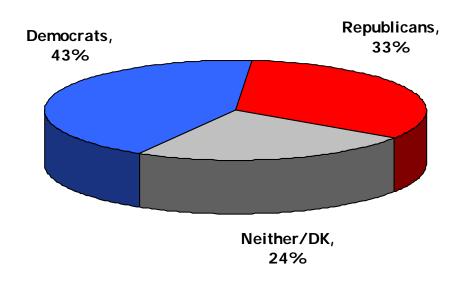

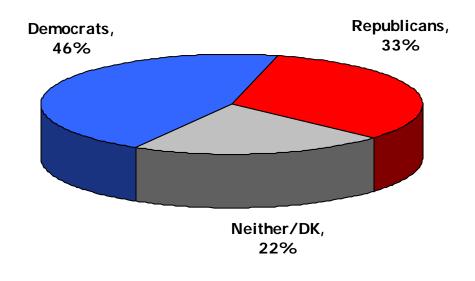

Generic Presidential Vote



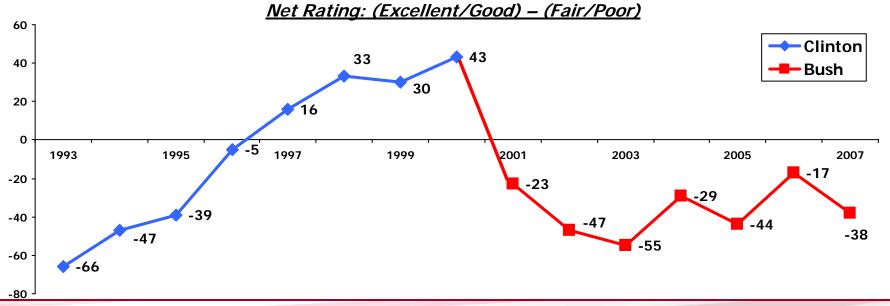

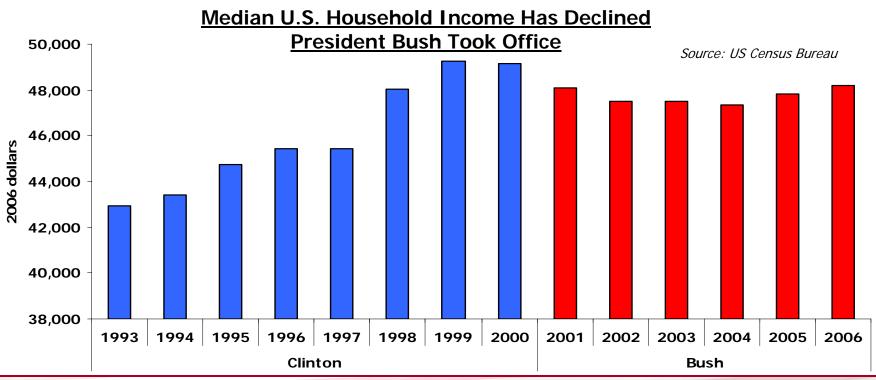
Rating of the Economy Over Time (Source: Gallup)





Only 18% are getting ahead, consistent with median income decline since 2000



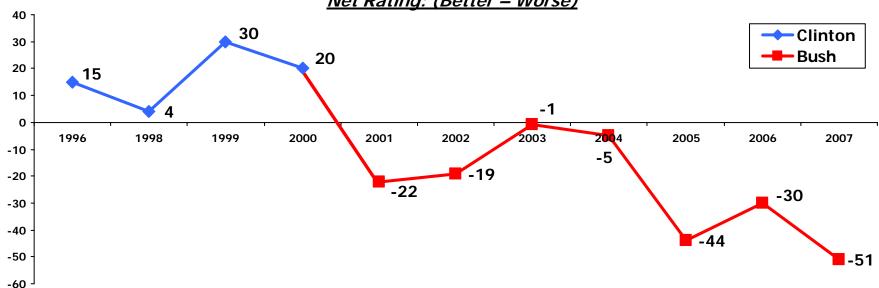

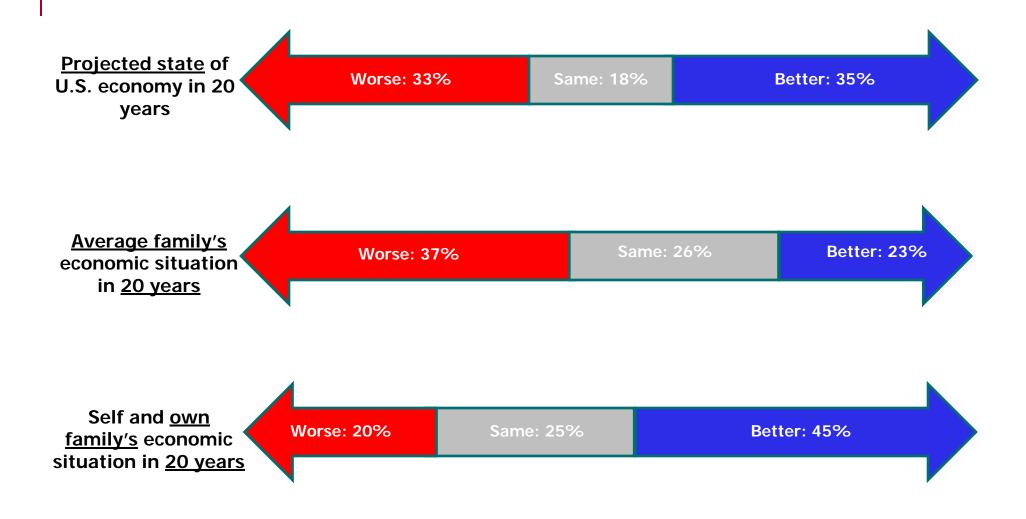


<u>Feelings about the Trajectory of the Economy Over Time (Source: Gallup)</u> Net Rating: (Better – Worse)





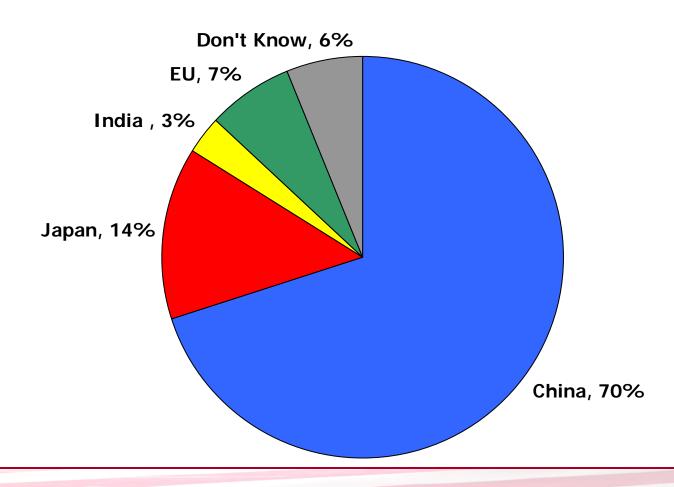

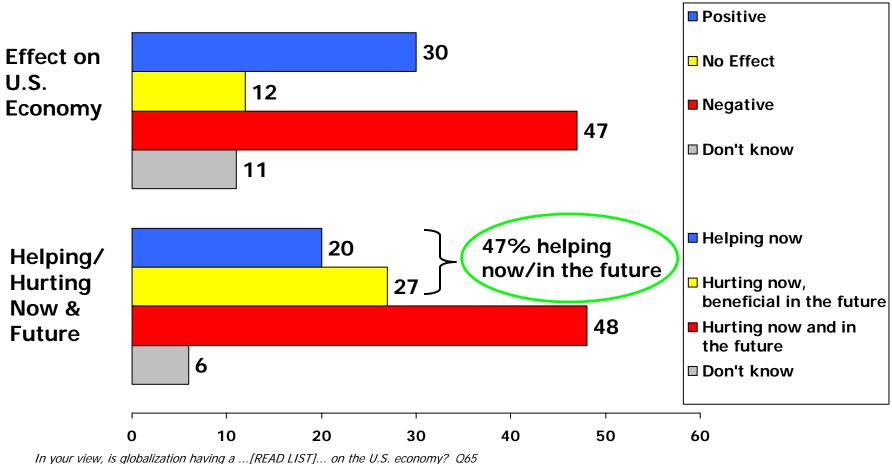
What globalization means to voters – borderless information sharing and lost jobs

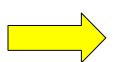

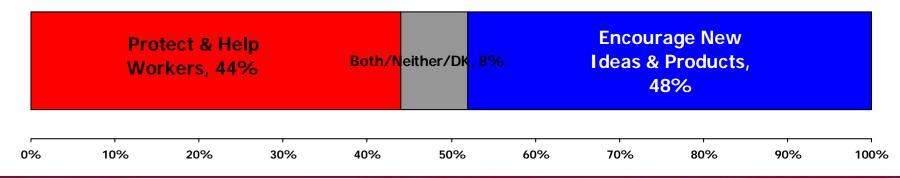
Preferred Economic Approach - Protectionism vs. Encouraging New Ideas: Plurality Favor Encouraging Innovation

Protect & Help Workers

Candidate A says the middle class is under siege and people are working harder than ever to make ends meet. Candidate A says we need to protect the middle class by including pro-worker provisions in new trade deals, holding trade partners to their commitments and investing more in dislocated workers and communities.

Encourage New Ideas & Products

Candidate B says we need a strategy for success in today's global economy. That means we must ensure trade agreements benefit workers but that will not be enough if we do not create new jobs. To do this, we must encourage the development of new ideas and new products, lower health care and energy costs, and invest in education.





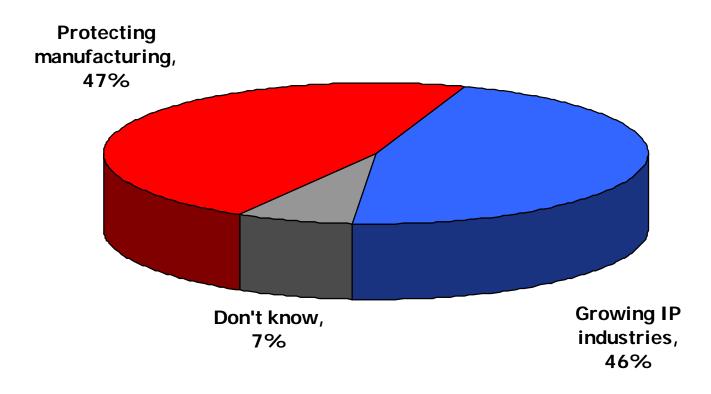

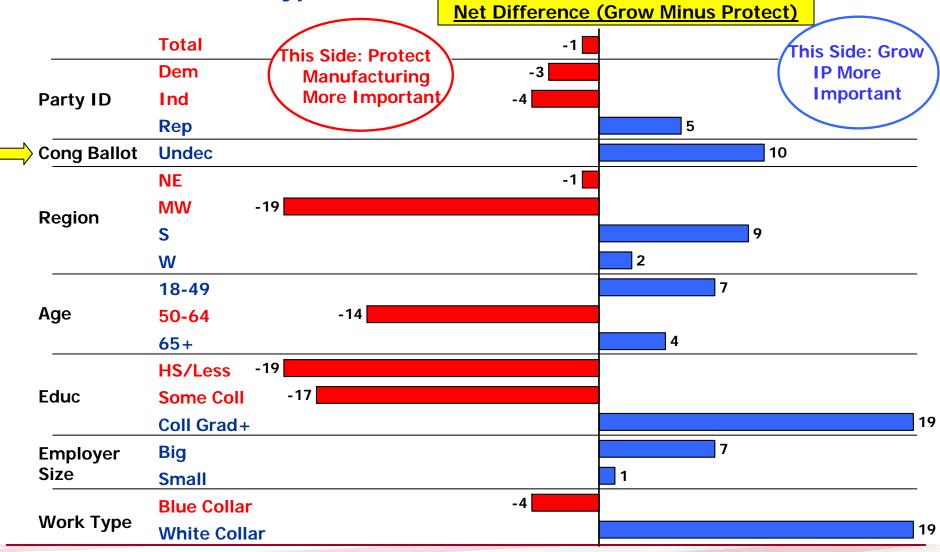

Grow Idea-Based Industries vs. Protect Manufacturing – Undecideds favor growing IP industries; Large differences between regions, age, education level, and type of work _____



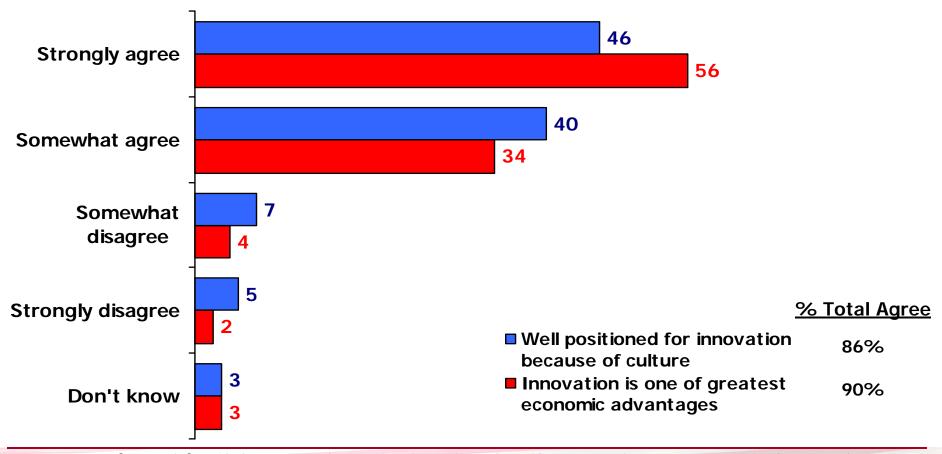

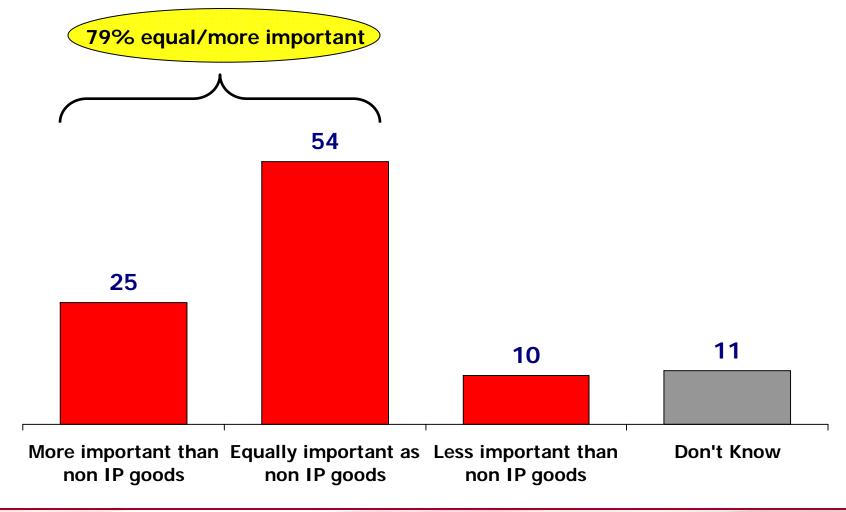

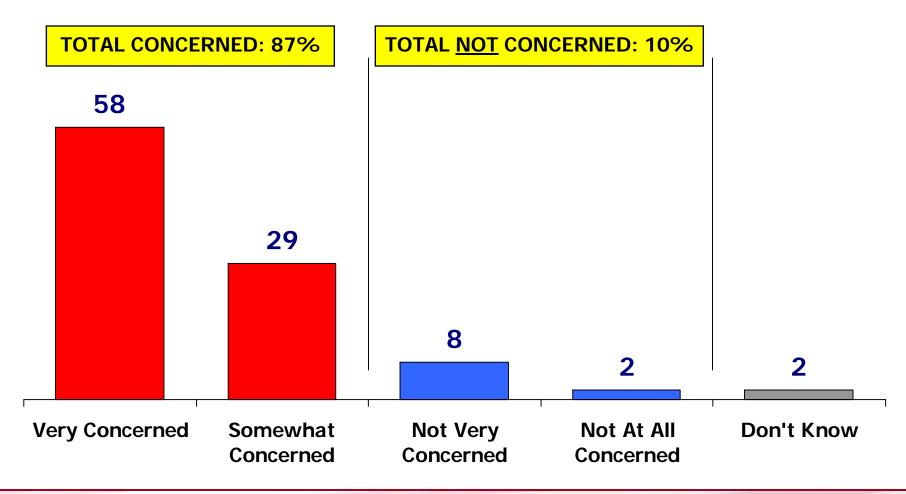

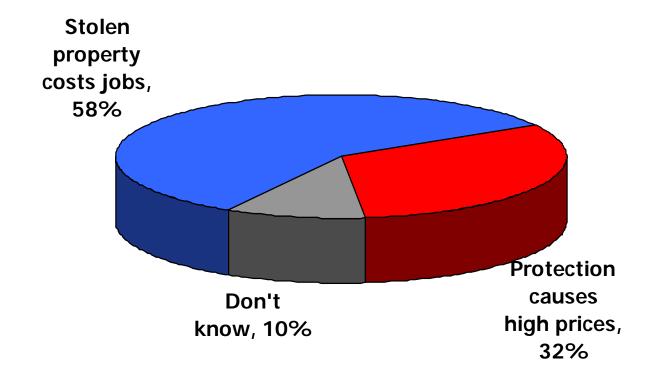
China's theft of American intellectual property is *very* troubling to a majority

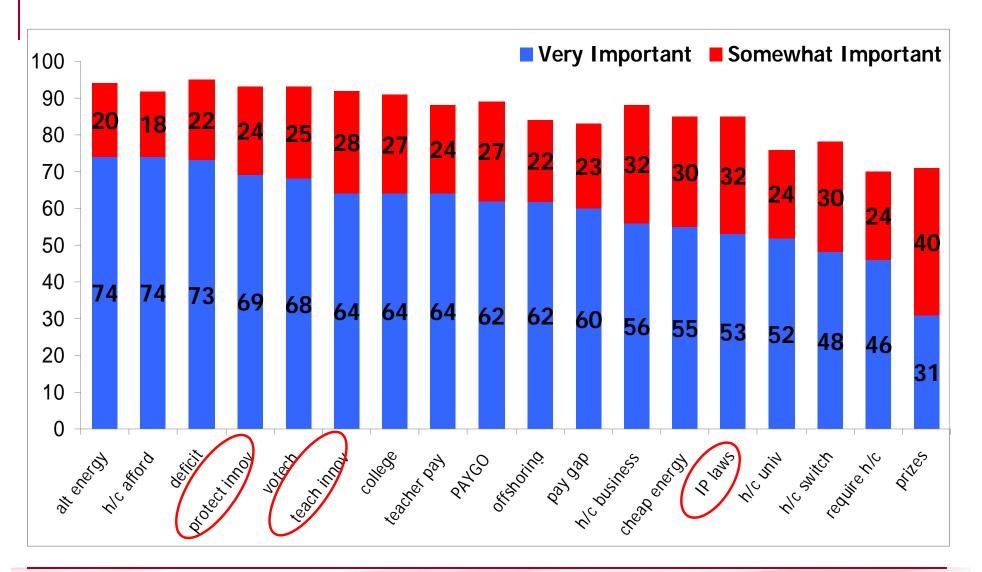

Economic Priorities: TOP FIVE

Alternative energy (74% very important, 94% total important) Increase incentives to produce alternative forms of energy to promote this as a new industry that will create new jobs.

Health care affordable (74% very important, 92% total important) Make affordable health care available to all American workers.

Deficit reduction (73% very important, 95% total important)Reduce the Federal budget deficit so the American government does not have to borrow money to run day to day operations.

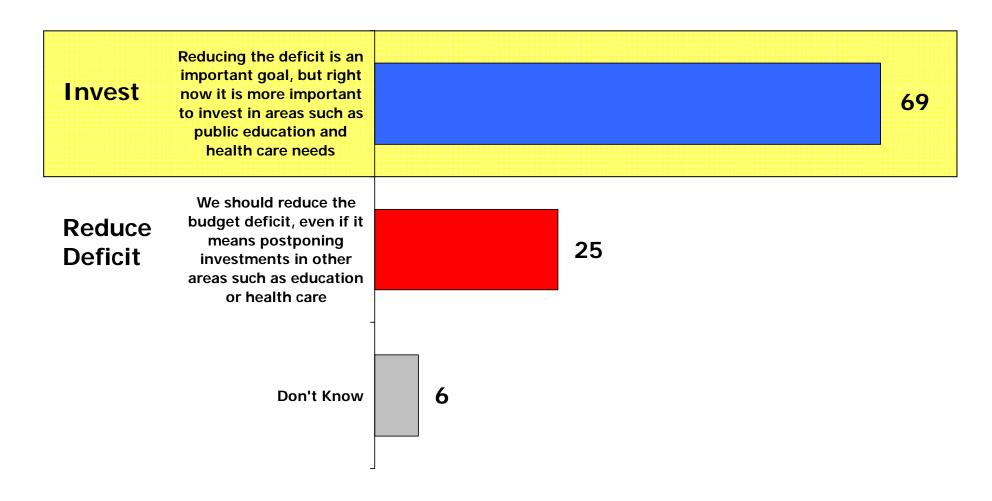
Protect Innovation (69% very important, 93% total important)
Help American companies protect their ideas and innovations from theft by foreign companies and foreign governments.

Increase vocational and skills training (68% very important, 93% total important)

Increase the availability of vocational and skills training for those students who do not want to attend college.

Economic Priorities: BOTTOM FIVE

Stronger IP laws (53% very important, 85% total important)

Strengthen international laws that protect the ideas and innovations that American companies produce from theft by foreign companies and foreign governments.

Health care universal (52% very important, 76% total important)

Provide universal health care coverage by expanding Medicare to cover all citizens.

Health care individual mandate (48% very important, 78% total important)

Instead of the current system that puts an emphasis on getting health care through a place of employment, switch to a new approach in which individuals would purchase their own insurance. Low-income individuals would be able to buy private insurance at a lower rate based on what they can afford.

Require Healthcare (48% very important, 78% total important)

Require all uninsured adults to purchase health insurance and provide subsidies for those people cannot afford to purchase the insurance.

Innovation Prizes (31% very important, 71% total important)

Create incentives such as government-funded cash prizes to encourage the development of scientific ideas that can lead to new products and industries.
